INTRODUCTION

At Harlem Multi One, LLC ("HMO" or "we" or "us" or "our") we take our responsibility to protect and respect your privacy seriously and want to be transparent regarding how we use and protect your data.

This policy describes the types of information HMO may collect from you when you visit our website www.1975Madsion.com (the "Website"). It also explains how we collect, use, maintain, protect, and, in some circumstances, disclose that information. Importantly, we do not sell personal information. Please note that if you are using the Website to access your investor portal account, the portal privacy policy and terms of use will also apply to you, and you should consult such policy and terms regularly for any updates.

Certain information we collect is required to operate the Website, others are necessary to complete our contractual or legal obligations. In some instances, we only collect information if you have expressly consented to such collection.

Please read this policy carefully to understand HMO's policies and practices regarding your information and how we will treat it. If you do not agree with HMO's policies and practices, you may choose to not provide us with the requested information or to decline to use the Website. By accessing or using the Website, you agree to this privacy policy.

We may change this policy from time to time (see "Changes to Our Privacy Policy"). We encourage you to review this policy each time you visit our Website. By visiting our Website, you agree to the terms of the most recent version of this policy.

INFORMATION WE COLLECT

Using Our Website:

Information You Provide

If you choose to contact us through the Website, you may be asked to provide certain personal information, including your:

Name
Company name and type
Telephone number
E-mail address
Questions and/or requests
We'll refer to this information, and any information that identifies, relates to, describes, references, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer, household, or device, as "personal information."

If you do not want us to have this information, you can choose not to provide it to us. (See "Your Choices").

Information We Collect Automatically

As you navigate through and interact with the Website, HMO may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns to support the security and usability of our Website, including:

information collected through cookies and other technologies;

demographic information, such as the country, state, and city from which you accessed our Website;

usage data including information about how you use our Website and what you do while you're there.

We'll refer to this information as "site-usage information" as it is information collected about your use of and interaction with the Website that does not reveal your specific identity.

While the information HMO automatically collects does not include directly personal data, it may include information that can be indirectly linked to you and we may maintain such data or associate it with personal information we collect in other ways. (See "How We Use Cookies and Similar Technologies" and "Google Analytics").

Use of De-Identified Data:

In some instances, we de-identify data by removing personal information. Once de-identified, the data is no longer attributed to a single unique individual. De-identified information is non-personal information that we may treat like other non-personal information.

HOW WE USE COOKIES AND SIMILAR TECHNOLOGIES

HMO uses different types of cookies to automatically collect certain data to improve your experience with the Website, to allow us to track certain information about your use of our Website, and to support the security of our Website. These include:

Cookies (or browser cookies). A cookie is a small file placed on the hard drive of your computer. When you first visit the Website, you are asked to consent to our use of cookies. You can decline the cookies; however, if you select this setting you may be unable to access certain parts of the Website. Unless you have declined cookies when you first visit or adjusted your browser setting so that it will refuse cookies, HMO's system will issue cookies when you direct your browser to the Website. For information about managing your privacy and security settings for cookies, see "Your Choices."

Web Beacons. Pages of the Website and HMO's emails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit HMO, for example, to count users who have visited those pages or opened an email, and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity).

GOOGLE ANALYTICS

The Website uses functions of Google Analytics, a web analysis service provided by Google Inc. ("Google"), 1600 Amphitheatre Parkway, Mountain View, CA 94043. Google Analytics uses cookies, that are saved to your computer and that allow your usage of the Website to be analyzed. The information generated by the cookie about your use of the Website (including your IP address) is generally transmitted to and stored by Google servers.

HOW WE USE YOUR INFORMATION

Using Our Website:

HMO uses information that we collect about you or that you provide to us when visiting the Website, including any personal information, for one or more of the following purposes:

To fulfill or meet the reason you provided the information. For example, if you share your name and contact information to ask a question about our products or services, we will use that personal information to respond to your inquiry.

To provide, support, personalize, and develop our Website, products, and services.

To provide you with newsletters, articles, alerts, announcements or other marketing information that HMO believes may be of interest to you;

To provide you with support and to respond to your inquiries, including to investigate and address your concerns and monitor and improve our responses.

To help maintain the safety, security, and integrity of our Website, databases and other technology assets, and business.

For testing, research, analysis, and product development, including to develop and improve our Website, products, and services.

To improve our business, enhancing the Website, identifying usage trends and determining the effectiveness of our promotional campaigns;

To respond to law enforcement requests and as required by applicable law, court order, or governmental regulations.

In other ways as described to you when collecting your personal information.

To evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by us about our Website users is among the assets transferred.

For any other purpose, with your consent.

HMO may also, with your consent, use your information to contact you about goods and services that may be of interest to you.

INFORMATION WE MAY DISCLOSE

First, we do not sell personal information. HMO values the information it has about people who access or interact with the Website and is not in the business of selling it to others. We do occasionally need to share your information for the purpose of conducting our business or to comply with legal obligations. For example, under certain circumstances, HMO may need to disclose collected personal information in order to:

disclose to service providers, such as leasing partners or brokers, who are contractually bound to use personal information solely to provide services on our behalf or as required by law and to maintain the confidentiality and security of such information;

carry out our obligations and enforce our rights arising from any contracts entered into between you and us;

enforce our terms and conditions;

comply with any court order, law, legal process, or to respond to any government or regulatory request, including requests related to laws outside of your country of residence;

protect the rights, property, or safety of HMO, its employees, customers, or others; permit us to pursue available remedies and/or limit the damages that we sustain;

fulfill our recordkeeping obligations and practices;

fulfill any other purpose disclosed by us when you provide the information;

comply with your instructions or, if allowed to do so, with your consent.

We may also need to provide the collected personal information to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of HMO's assets, whether as a going

concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by HMO's about the Website users is among the assets transferred.

HOW WE PROTECT YOUR INFORMATION

HMO's comprehensive information security program utilizes commercially reasonable practices with administrative, physical and technical safeguards in place designed to protect against anticipated threats or hazards to the security, confidentiality and integrity of HMO systems and information. Such practices include, but are not limited to, firewalls, multi-factor authentication, encryption, intrusion detection and data leakage tools, and personnel security and training.

YOUR CHOICES

You can always choose not to provide information, even though it might be needed to take advantage of some offers or features of the Website.

You can decline to accept cookies, set your browser to block cookies, or erase HMO's cookies from your computer, though doing so may prevent some aspects of the Website from working properly.

CHILDREN UNDER THE AGE OF 13

The Website is not intended for children under 13 years of age. No one under age 13 may provide any personal information to or on the Website. HMO does not knowingly collect personal information from children under 13. If you are under 13, do not use or provide any information on the Website, or provide any information about yourself to HMO, including your name, address, telephone number, or email address. If we learn that we have collected or received personal information from a child under 13 without verification of parental consent, the information will be deleted.
